Lighthouse is wholly owned by ShawKwei & Partners Ltd. which is holding the shares of Lighthouse on behalf of Asia Value Investment Fund 3, L.P..

Kyle Arnold Shaw, Jr, a director of PB, Lighthouse and the Company, is deemed to be interested in 173,267,967 Shares, representing approximately 83.17 per cent. of the Shares in issue before the general offer transaction. Kyle Arnold Shaw, Jr is (a) the sole manager of ShawKwei Investments LLC, which is the sole general partner of ShawKwei Asia Value Fund 2017 L.P., which wholly owns PB; and (b) the director and shareholder of ShawKwei & Partners Ltd., which is the sole shareholder of Lighthouse.
